Consider and Act 2026 Budget. Clerk Hann reviewed the Town Budget and updated Library Budget with a Contingency Fund of \$66,747. Chairman Klink said he has had a meeting with Library Director Iyengar to get to the numbers shown. A motion to approve the 2026 Budget was made by Fleming/Olson. Motion carried.

Consider and Act on Resolution Establishing the 2025 Town of Merton Fire Protection Fee. Clerk Hann review the resolution to establish the 2025 Fire Protection Fee Formula. The only changes are to the cost per square foot of a residential house and a commercial building. Commercial Buildings have a discount because they pay an inspection fee to the Fire Departments. Land Charges and Outbuilding Charges stayed the same. Supervisor Fleming asked about the Land Charges. Clerk Hann explained that charge was reduced in 2024 from the prior year. A motion to approve the Resolution Establishing the 2025 Town of Merton Fire Protection Fee was made by Fleming/Krogmann. Motion carried.

Consider and Act on Resolution accepting Canter Court as a Town Road. DPW Director Paul Griffin talked about the road work done in the new subdivision and recommending approving and start the one-year warranty period. A motion to approve Canter Court as a Town Road was made by Fleming/Herrick. Motion Carried.

Consider and Act on Request from Stone Bank Lions Club/Stone Bank Rec for \$11,250.96 for Improvements made at Stone Bank Park. Clerk Hann stated there was request for Park Funds approved at the Plan Commission Meeting on November 5, 2025 however after the meeting it was noticed that there was an addition error. Treasurer Kempen reviewed the numbers and stated the correct amount should be

\$10,409.91 A motion to approve reimbursing the corrected total of \$10,409.91 was made by Fleming/Herrick. Motion Carried.

Clerk, Board, Highway, Treasurer and Attorney Reports. Treasurer Kempen talked about working on getting everything entered for Tax Bills and the Preliminary Audit work will beginning the end of the month. DPW Director Paul Griffin said the 2008 International Truck was sold for \$31,500. Chairman Klink read an inspector report for Ken Nyhouse.

<u>Vouchers as Presented</u> - A motion to approve the vouchers as presented was made by Herrick/Olson. Motion carried.

<u>Quarterly Budget to Actual</u> - Treasurer Kempen presented the quarterly budget to actual report for 2025. A motion to approve the Budget to Actual report was made by Fleming/Herrick. Motion carried.

<u>Quarterly Journal</u> - A motion to approve the quarterly journal entries was made by Fleming/Olon. Motion carried.
